ODOT Main Street Bridge Replacement Project Detour: Council reviewed a request from Jerry Bantz, Transportation Engineer with ODOT District 3, to utilize Wally Road as a detour instead of the state route detour through Butler for approximately 10 days during the project. Administrator Young noted that ODOT advised they would repair any damage to Wally Road. Council discussed using South Mount Vernon Avenue, with Administrator Young noting that the reservoir replacement project could be underway at the same time. Councilman Young expressed concerns that Wally Road is too narrow for detour traffic. Councilwoman Cooper suggested the possibility of routing truck traffic onto South Mount Vernon Avenue and all other traffic onto Wally Road. After general discussion, Councilwoman Cooper moved to recommend to ODOT that the detour route for truck traffic be South Mount Vernon Avenue and all other traffic be directed to Wally Road. Second by Councilman Welsh. A roll upon said motion resulted as follows:

She noted that the current policies with Vision Service Plan, Delta Dental and Standard Life will remain the same for 2018, with the monthly premiums paid separately to each company for the health, vision, dental, and life plans rather than together as they were with OPEC. Councilwoman Cooper moved to accept the quote from Koppert Insurance for the Medical Mutual plan for 2018. Second by Councilman Welsh. A roll call upon said motion resulted as follows:
