

**ORDINANCE NO. 60-2018**

**AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR AND FISCAL OFFICER TO ENTER INTO A LEASE AGREEMENT WITH FIRST-KNOX NATIONAL BANK AND PURCHASE A 2019 FORD F350 FOR THE LOUDONVILLE MAINTENANCE DEPARTMENT.**

**WHEREAS**, the Council of the Village of Loudonville has determined that a true and real need exists for the acquisition of a 2019 Ford F350 for use by the Village of Loudonville Maintenance Department; and

**WHEREAS**, the Council has complied with the applicable laws and has taken the necessary steps to arrange for the acquisition by lease of said vehicle;

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF LOUDONVILLE, STATE OF OHIO:**

**SECTION 1:** That the Village Administrator and Fiscal Officer are hereby authorized and directed to purchase a 2019 Ford F350 from Cal Hans Ford and enter into a lease agreement with First-Knox National Bank, for said purchase for the initial principal amount not exceeding Forty-Nine Thousand Nine Hundred Ninety-Five Dollars (\$49,995.00) and consistent with the vehicle specifications set forth on Exhibit A, attached. Said lease agreement shall be for a term of five (5) years and shall accumulate interest at a rate not to exceed four percent (4.0%) per year.

**SECTION 2:** That the Council of the Village of Loudonville hereby represents that the reasonably anticipated amount of qualified tax-exempt obligations which have been and will be issued by the Village of Loudonville, does not exceed Ten Million and No/Dollars (\$10,000,000.00) for the calendar year within which this equipment lease purchase agreement is to be "qualified tax exempt obligation" pursuant to Section 265 (b) (3) of the Internal Revenue Code.
