The Loudonville Village Council met for a regular meeting on Monday, December 3, 2018 at 6 p.m. at the Loudonville Village Hall council chambers. Mayor Stricklen called the meeting to order and answering roll call were Mr. Bill Welsh, Mr. Tom Young, Mr. Michael Robinson, Mr. Jason Van Sickle, Mr. Tom Gallagher, and Mrs. Cathy Lance. Also in attendance at the meeting were Village Administrator Curt Young, Fiscal Officer Elaine Van Horn, Police Chief Kevin Taylor, Fire Chief Mike Carey, Loudonville Times Reporter Jim Brewer, along with Village residents Matt Young and Brandon Biddinger. Also attending were several visitors from the surrounding area including Toni Keppen, Annette McCormick and Dan Piskur.

THE PLEDGE OF ALLEGIANCE: Mayor Stricklen led the Pledge of Allegiance.

CONSENT ITEMS:

Council Minutes – November 19, 2018 regular meeting: Councilman Van Sickle moved the minutes be approved as presented. Second by Councilman Welsh. A roll call upon said motion resulted as follows:

Fracking Concerns: Ms. Toni Keppen asked Council if they were aware of the results of the seismic testing that was completed on Wally Road near the wastewater plant. Mayor Stricklen explained that the Village is not expected to receive the results as the testing was done by a private company for their own use, which was previously discussed at the November 19 Council meeting. Ms. Keppen questioned whether Council knew before they voted to allow the testing on Village property that they would not be privy to the results. Councilman Van Sickle stated that he was not aware that the Village might not hear the results. Ms. Keppen further questioned whether Cabot Oil & Gas had previously stated they would share the information received from the testing, with Councilman Van Sickle noting that it was not Cabot that asked permission to perform the testing but rather Precision Geophysical. Ms. Keppen asked Council if it was still their intention to refrain from allowing fracking on Village property even though they permitted the testing. Councilman Van Sickle stated that he felt that fracking in the Village was too big of an issue to put on the Village Council, further noting that while he was opposed, he could not speak for Council. Ms. Keppen thanked Councilman Van Sickle for his response.

DEPARTMENTAL REPORTS:

Reservoir Project: Administrator Young reported that the reservoir project final paperwork is being submitted to OWDA. He noted that the total cost is about \$7,000 below the contract price.
