NCL Service Line Warranty Program Agreement: Administrator Young reported he has received a proposed marketing agreement from NCL that he asked Solicitor Gilman to review as he had concerns with it. Solicitor Gilman stated that he reviewed the proposed agreement, which he noted would allow the company, Service Line Warranties of America, to use the Village logo and Village employee names in their advertising materials that they would distribute to residents. Solicitor Gilman recommended that that the Village refrain from entering into the marketing agreement with NCL, with Councilman Gallagher concurring. Councilwoman Lance noted she had researched the company through the Better Business Bureau and was also reluctant for the Village to enter into the agreement with them based on some unfavorable reviews. Solicitor Gilman noted that a vote of Council regarding the agreement was not necessary and no legislation would be prepared since Council wished to take no action.

Fireman Brad Dilgard noted that the equipment included grain entrapment rescue equipment. Mayor Stricklen noted that there were several Loudonville firefighters who attended a very rigorous training event for grain entrapment. Solicitor Gilman reminded Council that the Loudonville Fire Department Inc. is an organization separate of the Village of Loudonville, noting that the organization is made of up firefighters that are committed to raising funds to further support the growth and progress of the Fire Department.
