#### **ORDINANCE 9-2018**

# AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN ANNEXATION AGREEMENT WITH HANOVER TOWNSHIP AND MOHICAN CAMPGROUND LLC.

WHEREAS, Mohican Campground LLC has submitted a proposed Annexation Agreement to the Village of Loudonville, said agreement being attached hereto as Exhibit A; and

WHEREAS, the Village of Loudonville wishes to enter in an agreement for the annexation of land described in the attachment to said Annexation Agreement;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF LOUDONVILLE, STATE OF OHIO:

**SECTION 1:** That the Mayor of the Village of Loudonville is herby authorized to enter into an agreement with Hanover Township and Mohican Campground LLC, attached as Exhibit A, attached hereto and made part hereof by reference, for the annexation of the property described in the attachment to said Agreement.

**SECTION 2:** That this Ordinance shall take effect and be in force at the earliest date allowed by law.

### Exhibit A

#### ANNEXATION AGREEMENT

This Agreement is made effective upon the approval of both the Trustees of Hanover Township, Ashland County, Ohio and the Village of Loudonville, Ohio, and concerns the annexation of the real estate owned by Mohican Campground LLC, as further described on Exhibit "A" attached hereto and incorporated herein by reference.

Whereas, the real estate described on Exhibit "A" has heretofore been a part of Hanover Township;

Whereas, the owner of the real estate, Mohican Campground LLC, is seeking to have the same annexed into the Village of Loudonville, Ohio pursuant to the annexation procedure set forth in sections 709.021 and 709.022 of the Ohio Revised Code.

Whereas, this Agreement is entered into and is intended to constitute an Annexation Agreement within the meaning of Section 709.022 of the Ohio Revised Code.

# **NOW, THEREFORE,** the parties hereto agree as follows:

- 1. Hanover Township, Ashland County Ohio, by and through its Trustees and the Village of Loundonville, Ohio, an Ohio municipal corporation, hereby agree and consent to the annexation of the property describe on Exhibit "A" into the Village of Loudonville, Ohio.
- 2. The Village of Loudonville agrees to provide sewer and water services to the property described on Exhibit "A" after the same is annexed to the Village of Loudonville, according to the same terms and conditions as such services are available to other areas and properties located within the corporate limits of the Village, pursuant to Village Ordinances.
- 3. The parties agree that Hanover Township has no indebtedness which is to be apportioned pursuant to Section 709.12 of the Ohio Revised Code.
- 4. The parties agree that the Minimum Mandated Levies established pursuant to Section 5705.31 of the Ohio Revised Code shall be allocated in the same manner as those levies are allocated for other portions of Hanover Township that are also located within the Village of Loudonville.
- 5. The parties agree that upon the effective date of the annexation, the territory to be annexed shall be treated, for all purposes not specifically referred to

herein, in the same manner as other territory located within Hanover Township that is also located within the Village of Loudonville.

- 6. Hanover Township does hereby waive any objections it has to this annexation and waives any rights it may have to contest or appeal such annexation.
- 7. The parties agree to participate in any meetings, hearings, or the preparation of further documentation for the Ashland County Commissioners, for the completion of this annexation.
- 8. The undersigned further certify that all deliberations concerning the matters addressed by this agreement, and any action taken by the legislative authority of either local government body, all occurred during a public meeting and in full compliance with the open meetings laws of the State of Ohio.
