RESOLVED, by the Village, two thirds of all members elected thereto concurring as follows:

\$96,480.00. Now, therefore, be it

1. The Village desires and determines to proceed with the submission of the question of a tax levy at the rate of four and five-tenths (4.5) mills for each one dollar of valuation, which amounts to forty-five cents (\$0.45) for each one hundred dollars (\$100.00) of valuation, to the electors of the Village for the benefit of the Village of Loudonville, Ohio for the purpose of providing for current expenses of the Village, at a rate not exceeding four and five-tenths (4.5) mills for each one dollar of tax valuation of the taxable property within said District, which

amounts to forty-five cents (\$.45) for each One Hundred Dollars (\$100.00) of the tax valuation of the taxable property within said District.

2.	The tax levy, which is is a renewal of an existing levy of four and five-tenths (4.5) mills, will be for five (5) years, and such levy will be placed upon the current tax list commencing January 1, 2019, first due in calendar year 2020, if a majority of the electors voting thereon vote in favor thereof.			
3.	The question of such tax levy shall be submitted to the electors of the Village at the election to be held therein on November 6, 2018.			
4.	The Fiscal Officer of the Village is hereby directed to certify, not less than 90 days prior to the election, to the Board of Elections of the County, a copy of the resolution of necessity dated and a copy of this resolution together with the certification of the County Auditor, and notify the Board of Elections to cause notice of election on the question of levying the tax to be given as required by law.			
5.	It is found and determined that all formal actions of this Village concerning and relating to the adoption of this resolution were adopted in an open meeting of this Village, and that all deliberations of this Village and of any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with Ohio law.
